Join a NARUC tour of Louisville Gas & Electric's Mill Creek Generating Station, a 1465-MW, four-unit coal-fired power plant in southwest Louisville. In operation since 1972, Mill Creek has implemented advanced pollution controls to reduce SO₂, mercury, and particulate emissions.

Thanks to the U.S. Department of Energy, NARUC is offering an exclusive tour of the plant

to MACRUC commissioners and commission staff. Round-trip transportation between the Brown Hotel and Mill Creek and lunch will be provided by NARUC.
